1. SCALES SHOWN ON THIS PLAN ARE APPROXIMATE.
2. DIMENSIONS SHOW THE BOUNDARIES OF A SPEED LIMIT FOR THE PURPOSES OF THE BYLAW.
3. SPEED LIMIT BOUNDARIES THAT CROSS A ROAD DO SO AT RIGHT ANGLES FROM ONE SIDE OF THE ROAD TO THE OTHER, BY THE SHORTEST DISTANCE.
4. A SPEED LIMIT BOUNDARY MARKED ALONG A ROAD IS DEEMED TO RUN ALONG THE EDGE OF THE CARRIAGEWAY.
5. ALL KAPITI COAST DISTRICT COUNCIL ROADS SHOWN ON THIS MAP OUTSIDE THE URBAN TRAFFIC AREA HAVE A SPEED LIMIT OF 100 KM/H EXCEPT FOR THOSE ROADS OR AREAS MARKED WITH A DIFFERENT SPEED LIMIT.
6. SPEED LIMITS ON STATE HIGHWAYS ARE NOT PART OF THE KAPITI COAST DISTRICT COUNCIL SPEED LIMIT BYLAW 2005. REFER TO THE TRANSIT NEW ZEALAND SPEED LIMITS BYLAW FOR SPEED LIMITS ON STATE HIGHWAYS.
