Submission on Proposed Plan Change 4 (Private) – Welhom Developments Ltd

REASON FOR SUBMISSION

- The Greater Wellington Regional Council (Greater Wellington) wishes to make a submission on Proposed Plan Change 4 (the Plan Change) pursuant to Schedule 1 clause 6 of the Resource Management Act 1991 (the Act). This submission is from Greater Wellington officers.
- 2. The Plan Change is to re-zone a site from Rural Lifestyle Zone to General Residential Zone and to add a new Development Area for the site with a Structure Plan and new site-specific policies and rules.
- 3. Responses to specific provisions are included in Attachment 1 and should be read alongside this letter.

Proposed Change 1 of the Regional Policy Statement for the Wellington Region

- 4. The Regional Policy Statement for the Wellington region (RPS) is a regional document that identifies significant resource management issues within the region and sets out the objectives, policies and methods to achieve integrated management of natural and physical resources for the Wellington region. The RPS was made operative on 24 April 2013.
- 5. Proposed Change 1 of the Regional Policy Statement for the Wellington Region (RPS Change 1) will implement and support the National Policy Statement on Urban Development 2020 and start the implementation of the National Policy Statement for Freshwater Management 2020. RPS Change 1 encourages more intensive urban development in appropriate locations, guides how Te Mana o Te Wai applies to



freshwater in the region, and strengthens existing provisions for indigenous ecosystems. Greater Wellington publicly notified its Decisions on RPS Change 1 on 4 October 2024.

6. Part of RPS Change 1 is a 'freshwater planning instrument' and therefore subject to the freshwater planning process under Section 80A and Part 4 of Schedule 1 of Act. The provisions that are part of the 'freshwater planning instrument' are now fully operative.

Protection of indigenous biodiversity

7. Greater Wellington appreciates the efforts to ensure that future development of the site prioritises the use of nature-based solutions to provide for climate change mitigation, adaptation, and resilience. The proposed provisions require the construction of onsite inland wetlands to provide flood storage capability for events up to a 1% AEP event and ensure a net-positive environmental gain. Greater Wellington considers the intent of those provisions is consistent with Policy CC.4, Policy CC.14, Policy 40A, Policy 40B, Policy 41, and Policy 42 of the RPS and Policy 24A of RPS Change 1.

Giving effect to Te Mana o te Wai

8. Greater Wellington notes the efforts to give effect to the Te Mana o te Wai hierarchy of obligations through the proposed provisions. The proposed provisions set out that the primary function of offset areas will be to create natural inland wetlands and the secondary function will be to provide flood storage and stormwater treatment functions. Greater Wellington considers the intent of those provisions is consistent with Policy FW.3 of the RPS.

RELIEF SOUGHT

Greater Wellington requests that amendments are made where sought in this submission, and any necessary consequential amendments.

FURTHER INVOLVEMENT

10. Greater Wellington wishes to be heard in support of its submission. We would also welcome the opportunity to clarify and further discuss the matters raised.
