S107.01 Support in part - As per Landlink's initial submission we believe that further clarify is required around flood risk and MDRH. We also agree that that it is not feasible to manage flood risk retrospectively through the application of subdivision rules when landuse, and therefore effects, have been legally established.

S107.2 Support in part - support a change to include that approved building consent could be used to demonstrate compliance with the rule. As per Landlink's initial submission you do not receive 'approved' land use for a permitted activity therefore rule requires amendment/clarification
