## CONTRACTS UNDER DELEGATED AUTHORITY

# **PURPOSE OF REPORT**

This report provides an update on any contracts over \$250,000 accepted under delegated authority for the period 1 July to 30 September 2017.

# Delegation

The Operations and Finance Committee has delegated authority to consider this report under the following delegation in the Governance Structure, Section B.2.

This Committee will deal with monitoring and decision-making on all broader financial management matters, including approval of contracts and contract variations outside the Chief Executive's delegations.

#### Issues

## Contract 2017/C136 - Streetlighting Luminaire Upgrade

- Three tenders were received, ranging from \$1,012,805 to \$1,370,275.
- 4 The Contract was awarded to Fulton Hogan for the sum of \$1,012,805.
- Fulton Hogan is a local contractor and they will be sourcing the LED luminaires from manufacturers outside the region.

## Contract 2017/C142 - Kapiti Lights Coastlands Public Space P3A

- No tenders as the Contractor is already engaged as part of the town centre works. This contract will partially be funded by Coastlands and Kapiti Lights.
- 7 The Town Centre Contract was awarded to Brian Perry Civil for the sum of \$314,079.
- 8 Brian Perry Civil has estimated 70% of the contract will be sourced locally i.e. wages, material and supplier wherever possible.

#### Contract - Provision of Valuation Services

9 No tenders were required as Kāpiti Coast District Council, together with all Councils in the Wellington Region (Wellington Group), are parties to a current contract for the provision of Database Management Services (contract). The contract provides the Wellington Group with the option to extend the contract for a further three year term to 30 June 2020.

- 10 The Wellington Group agreed to extend the contract for the following reasons:
  - a) this option to extend was provided by the original contract;
  - b) there are very limited valuation service providers in the Wellington Region;
  - c) at the time of the contract extension, Hutt City Council and Porirua City Council were undertaking their three yearly property valuations; and
  - d) the Wellington Group made best use of the contract extension to modify the current levels of service.
- The contract with Quotable Value Limited was extended for three years ended 30 June 2020 and Kāpiti Coast District Council's total contract cost is \$890,148 plus GST,

#### Considerations

12 There are no financial, legal, consultation and publicity considerations.

#### SIGNIFICANCE OF DECISION

13 The Council's significance policy is not triggered.
