MATTERS OF AN URGENT NATURE:

Mrs Boonen referred to her email to the Chair regarding the Trans-Pacific Partnership Agreement (TPPA) being signed in early February 2016. She said the Board had previously recommended to Council to adopt a 12 point statement and Council had resolved to accept the statement.

The Chair confirmed he had received notification about this matter and had forwarded the email onto the Board.

The Board passed a resolution agreeing to consider the matter under urgency.

MOVED (Edwards/Buchanan)

That the Board approved of Mrs Boonen's request for the TPPA matter to be heard under a Matter of An Urgent Nature because of the time constraints.

CARRIED

Mrs Boonen said at a Greater Wellington Regional Council (GWRC) meeting, Cr Bruce had taken a notice of motion to address this matter urgently to Local Government New Zealand (LGNZ) and requested an independent analysis on the TPPA text and that that information was expected to become available soon. Mrs Boonen asked that the Board to support GWRC's motion and to put that to the Kāpiti Coast District Council.

Mr Mallon said the matter had been raised at the rural provincial meeting with LGNZ and a similar motion asking LGNZ to investigate the matter further had been lost. Mr Mallon said he was happy to follow-up and confirm LGNZ's position.

Ms Starbuck-Maffey confirmed an approach had already been made by Dr Viola Palmer to include this matter on Council's 10 December agenda but was declined. However, the Council's next meeting on 28 January 2016 would be better placed to consider the matter.

Cr Holborow said Councillors liked to have all the information before them and raising as a matter of an urgent nature was likely to be lost.

The Board discussed making a resolution to ask:

- LGNZ to investigate further; and
- the Board Chair to meet with the Mayor to discuss Council's previous request to LGNZ.

The Mayor said Council, as well as numerous other Councils had already asked LGNZ to find out where the TPPA matters were at with Central Government.
