CONTRACTS UNDER DELEGATED AUTHORITY

PURPOSE OF REPORT

- 1 To report on contracts over \$250,000 accepted under delegated authority for the period 1 February to 31 March 2015.

Delegation

- 2 The Corporate Business Committee has delegated authority to consider this issue. Reference B.3.7 of the Governance Structure which reads:

Without limiting the generality of this delegation, the committee has the following functions, duties and powers.

Financial and Asset Management

7.5 Authority to monitor performance of the Council's financial activities, including income, operating and capital expenditure against budgets, remissions, key financial indicators and investment and debt/borrowings management.

CONSIDERATIONS

Contract 2014/C025 Watermain Renewals Ames Street, Paekākāriki and Manly Street, Paraparaumu

- 3 Nine tenders were received, ranging in price from \$557,871 to \$949,687.
- 4 The Contract was awarded to Dews Construction Ltd with a reduced scope of works to meet available budget for the sum of \$447,802 based on the weighted attributes, quality price method.
- 5 Dews Construction Ltd estimated that 10% of the total contract would be local content (materials sourced locally - Hynds, Winstone).

Contract 2014/C019 Wastewater Renewals 2014/15

- 6 One tender was received at \$461,583 and awarded to Interflow (NZ) Ltd.
- 7 Interflow estimated that 15% of the total contract would be local content (materials sourced locally – Hynds, Winstone and subcontract, Tatana Contracting)

Financial Considerations

- 8 There are no financial, legal, consultation and publicity considerations.

SIGNIFICANCE AND ENGAGEMENT

9 This matter has a low level of significance under the Council Policy.
