SIGNIFICANCE OF DECISION

6 Applicants;

- 6.1 The Kāpiti Concert Orchestra has applied for a grant for \$500 to assist with the costs of hall hire and a conductor's fee for a live concert in April 2011.
- 6.2 The Hearing in Kapiti Trust has applied for a grant for \$500 to assist with the costs of providing Soundfield systems to school's on the Kapiti Coast.
- 6.3 Nimlin Productions has applied for a grant for \$500 to assist with the costs of film stock to complete documentaries on the history of Te Horo and The Greater Ōtaki Project.
- 6.4 Carol Ward for the Christchurch Earthquake Appeal has applied for a grant for \$64.40 to assist with the costs of a liquor license.
- 6.5 Ōtaki College has applied for a grant for \$500 to assist with the costs of purchasing cultural gifts and an English speaking guide for their trip to Japan in April 2011.
