

## PUBLIC NOTIFICATION OF AN APPLICATION FOR RESOURCE CONSENT PURSUANT TO SECTION 95A OF THE RESOURCE MANAGEMENT ACT 1991

In accordance with section 95A of the Resource Management Act 1991, the Kāpiti Coast District Council gives notice of the following application for resource consent:

APPLICANT: APN Outdoor Limited.

LOCATION: State Highway One (Cnr. Elizabeth Street and Main Road), Waikanae. The application site is legally described as North Island Main Trunk.

PROPOSAL: **LANDUSE CONSENT – TO CONSTRUCT A DOUBLE-SIDED BILLBOARD FOR ADVERTISING PURPOSES**

The proposed billboard will:

- Comprise two signs each measuring 3m by 6m (18m<sup>2</sup>), and positioned 45° to each other;
- Be elevated at least 3m above ground level and reach a maximum height of 6m above ground level;
- Be supported by a single pole;
- Display static graphics or images (not illuminated), with images being changed, at its most frequently, on a monthly basis.

The proposed billboard is shown in the images below. Note: the graphic shown is indicative only.



The site is zoned Residential under the Kāpiti Coast District Plan and the proposal is a Non Complying activity.
