## **PUBLIC NOTICE**

## OF PROPOSED VARIATION NUMBER 1 TO THE PROPOSED KAPITI COAST DISTRICT PLAN (URBAN TREE VARIATION)

Pursuant to Clause 5 of Schedule 1 of the Resource Management Act 1991, the Kāpiti Coast District Council gives public notice of Proposed Variation Number 1 to the Proposed Kāpiti Coast District Plan. Proposed Variation Number 1 proposes amendments to Chapters 1, 2, 3, 4, 5, 6 and 10 of the Proposed Kāpiti Coast District Plan addressing the management and protection of indigenous trees within the urban areas of Ōtaki, Waikanae and Paraparaumu/Raumati that have reticulated water supply and sewerage. Proposed Variation Number 1 arises from the requirements of sections 76 (4A), (4B), (4C) and (4D) of the Resource Management Act 1991.

The submission must be in the prescribed form (Form 5 of the Resource Management (Forms, Fees and Procedure)
Regulations 2003), or similar. It must be dated, signed by you (unless you make your submission electronically), and must include:

- 1. your name, postal address and contact details;
- 2. the specific provisions of Proposed Variation Number 1 to which your submission relates;
- your position on the specific provisions (including whether you support or oppose the specific provisions or wish to have them amended) and the reasons for your views;
- 4. the decision you wish Kapiti Coast District Council to make in relation to those specific provisions of Proposed Variation Number 1; and
- 5. whether you wish to be heard at a hearing in support of your submission.

The submission form available on the Council's website includes fields for all of the above required information. Printed copies of the submission form are also available at the above-listed Council service centres

## The closing date for submissions is 4pm on Friday 30 October 2015.

**PROCESS:** Once Council has received submissions on Proposed Variation Number 1, these will be summarised and the summary will be publicly notified. There will be an opportunity to make a further submission in support of, or in opposition to, the submissions already made. Once further submissions have been received, reports will be prepared and public hearings will be held to hear the submissions before the Council makes its decisions. Following hearings, the Council must give its decision on the proposed variation (including its reasons for accepting or rejecting submissions). Any person who makes a submission has the right to appeal the Council's decision to the Environment Court.
