# **UPDATE: PEKA PEKA TO ŌTAKI EXPRESSWAY - NZTA**

# **Public Speakers**

## Lisa Burns

Ms Burns spoke to the Board about the expressway and the associated noise and visual effects that the residents will have. Ms Burns said there has been no meaningful consultation with NZTA and there is no mitigation for the properties along the expressway.

## Sarah Brown-Maclean

Ms Brown-Maclean spoke to the Board about her concerns with the gateway sculpture and the locations that have been proposed. Ms Brown-Macklean said having this sculpture close to residents properties will mean people will have full view into some properties and there will be noise pollution and the possibility of people freedom camping.

Cr Cootes provided an update that he had organised a meeting with the Chief Executive, Mayor and Ms Burns to discuss the residents issues.

Cr Cootes also extended an invitation to the Mayor to attend the next Gateway Steering Group Meeting.

Jamie McDuff, NZTA provided an update which included the following:

- A paper is going to the NZTA Board this week on the Shared Pathway, so there should be a decision in the next month;
- There has been a business case prepared for the PekaPeka interchange proposal, it will then be narrowed down to a preferred option, and then consultation will start;
- Fletchers and NZTA will be having a workshop around the noise plan and having a detailed look into this. There will be additional modelling completed;
- Discussions are underway around what type of sealing was used, the M2PP project and the process around the upgrading of it.
