# 4 HE WĀ KŌRERO KI TE MAREA | PUBLIC SPEAKING TIME

Pryor Rowland and Margaret Gordon spoke to the appended submission regarding recent dog attacks on birdlife in the Waimeha Lagoon Wildlife Reserve. Mr Rowland and Ms Gordon requested the board endorse the recommendations included in the submission, and answered members' questions. Council staff would provide further information to the Board regarding this matter.

Charlie Hopkins, on behalf of the Palmer and Cook Developments, spoke in support of the name 'Nga Koru Place' within Item 8.3 *Road Naming - 14 Ngarara Road, Waikanae* on the agenda. Mr Hopkins answered members' questions.

Sarah Yanez, on behalf of the Waikanae Business Association, provided an update on the Association's recent activities, including new members, and preparation for upcoming Christmas events. Ms Yanez noted the Association's support for opening the new pop up space at 56-62 Main Road, Waikanae. Ms Yanez also spoke to concerns regarding the temporary events process and the number of seasonal markets within the region, and requested that key stakeholders are consulted ahead of local seasonal markets.

Sarah Yanez, on behalf of Martin Bohanna, spoke to recent roadworks outside the Waikanae Fire Station on Te Moana Road. Ms Yanez relayed that traffic cones had been placed directly outside the Station's entrance, resulting in an incident with a departing fire truck, which had delayed the Waikanae Fire Brigade's attendance at a callout. Ms Yanez also noted Mr Bohanna's concerns with the short notice businesses had received regarding roadworks along the Old Main Highway at the southern entrance to the Waikanae township, and the financial impact on the affected businesses. Ms Yanez answered members' questions.

The Chair noted the incident outside the Waikanae Fire Station would be recorded in a service request to Council.

Andrew Annakin, on behalf of Te Horo Hall Society, spoke to an appended presentation providing an update on the progress with earthquake strengthening and renovation of the Te Horo Community Hall. Mr Annakin answered members' questions.
