HEARING OF SUBMITTERS: PUBLIC PLACES BYLAW

Jill Stansfield spoke about the section in the draft Public Places Bylaw around wellbeing and enjoyment in public places. She said that when public events are happening in public places that it should be easy for people with disabilities to access events, and that if walkways or cycleways run through event sites, the right health and safety measures are required.

Neil Hobson spoke about freedom camping in the draft Public Places Bylaw. The Bylaw needs more detail on freedom camping and also enforcement particularly at Waimanu Lagoon in Waikanae.

Ms Muir, Environmental Standards Manager provided the following update:

- the Parks and Reserves team have put some funding aside to improve the signage around freedom camping;
- Ms Muir provided some statistics about freedom camping in the Kāpiti district;
- Work is being done around Enforcement in these areas.

Neil Hobson on behalf of Roger Marchant spoke about Freedom camping. Mr Marchant is happy to see people using the reserve but the use must be sustainable. The grassed area needs protection and the parking needs to be clearly designated.

Pene Burton-Bell spoke about Public Places Bylaw and was happy to see more emphasis on protection of flora and fauna. She stated that there needs to be further investigation around drones which are not specifically mentioned in the Bylaw.

Clive Brugh spoke about freedom camping particularly at Waikanae Beach. He stated that freedom camping has got out of control in this area and that there are effects on the ecosystem in the area. The freedom camping policy needs to be changed to a bylaw.

Jocelyn Prvanov on behalf of the Waikanae Community Board spoke about the Freedom Camping Policy. The Board supports this policy but it is not working in the community and it is not enforced. The Board are aware of excess freedom camping vehicles at the Waikanae River. The Board support that the freedom camping policy needs to be changed to a bylaw.

PRESENTATION: PREDATOR FREE 2050

Mr Rob Stone from the Department of Conservation spoke to the Committee about Predator Free 2050. This is a National Strategy to eradicate possums, rats and stoats by 2050.

Predator Free 2050 has four 2025 interim goals

- have an extra 1 million ha under control;
- have large predator free areas without fences;
- have predator free offshore island nature reserves; and

- to have one new science breakthrough.

Predator Free 2050 are working with central and local government. The Predator Free 2050 Board and DOC are keen to work with the Kāpiti Coast District Council and Community groups.

URBAN DEVELOPMENT AUTHORITIES SUBMISSION (SP-17-188)

Ms Suzanne Rushmere, Policy Planner spoke to this report and outlined the submission. Ms Stevenson provided an outline of what the costs would be for this project.

The main points that emerged from discussions were:

- whether there is flexibility on how the Urban Development Authority (UDA) will look;
- concerns around the ability for UDA's to require Territorial Authorities to amend bylaws, which would have resource implications;
- concerns around the ability for the UDAs to require funding for infrastructure;
- concerns around having to accept an infrastructure asset at the end of the development period, which would have maintenance costs that the Council would have to cover;
- that reference be made to Te Whakaminenga in regards to our partnership with them and also reference to post treaty settlement entities.
- concerns around the financial impact and matters of uncertainty around the UDA;
- the importance of territorial authorities right of veto.

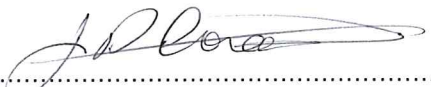
