## About preparing a further submission on a proposed plan change

### You must use the prescribed form

- [Clause 8](#), Schedule 1 of the Resource Management Act 1991 (RMA) requires further submissions to be on the prescribed form.
- The prescribed form is set out in [Form 6](#), Schedule 1 of the Resource Management (Forms, Fees, and Procedure) Regulations 2003.
- This template is based on Form 6. While you do not have to use this template, your submission must be in accordance with Form 6.

### Certain persons may make further submissions

- Under clause 8, Schedule 1 of the RMA the following persons may make a further submission, in the prescribed form, on a proposed plan to the relevant local authority:
  - any person representing a relevant aspect of the public interest
  - any person that has an interest in the proposed policy statement or plan greater than the interest that the general public has
  - the local authority itself.
- You will need to explain why you meet one of these categories (space is provided in the form for this below).

### Your further submission and contact details will be made publicly available

- [Section 352](#) of the RMA allows you to choose your email to be your address for service. If you select this option, you can also request your postal address be withheld from being publicly available. To choose this option please tick the relevant boxes below.

### Note to person making the submission

- A copy of your further submission must be served on the original submitter within 5 working days after it is served on the local authority (Kāpiti Coast District Council).

### Reasons why a further submission may be struck out

Please note that your further submission (or part of your further submission) may be struck out if the authority is satisfied that at least 1 of the following applies to the further submission (or part of the further submission):

- it is frivolous or vexatious
- it discloses no reasonable or relevant case
- it would be an abuse of the hearing process to allow the submission (or the part) to be taken further
- it contains offensive language
- it is supported only by material that purports to be independent expert evidence, but has been prepared by a person who is not independent or who does not have sufficient specialised knowledge or skill to give expert advice on the matter.

S097.01 - GWRC

S097.04 - GWRC - support in part - stormwater needs to be managed and allowed for as a qualifying matter and a qualifying matter precinct that aligns with natural hazards including inundation should adopted.

S097.06 - GWRC - support in part - climate change - amend PC 2 to introduce a qualifying zone to allow for managed retreat and risk of natural hazards including inundation.

S097.15 - GWRC - support in part - Natural Hazards - amend PC 2 to introduce a qualifying zone to allow for managed retreat and risk of natural hazards including inundation.

S097.21 - GWRC - support in part - Natural Hazards - amend PC 2 to introduce a qualifying zone to allow for managed retreat and risk of natural hazards including inundation.

S097.22 - GWRC - support if it is suggesting MDRS be excluded from the DP by way of a qualifying zone for natural hazards including stormwater so that intensification occurs in appropriate areas.

S097.28 - GWRC - support in part - intensification should only occur where there is sufficient three waters network capacity, including stormwater disposal.

S097.36 - GWRC - special character - support GWRC and special character should be a qualifying matter precinct.

S097.46 - GWRC - coastal qualifying matter precinct - support GWRC and the precinct should be enlarged to the entire coastal zone until KCDC has an effects based response to all matters of natural hazards in the coastal environment.
