### GAC 17/02/004 HERITAGE FUND ALLOCATIONS 2015-16 (CS-17-086)

Mr Rob Cross, Programme Manager Biodiversity, spoke to the report which summarises applications for grants from the Heritage Fund in 2016-2017 and makes recommendations on funding allocations. He said all applications met the criteria and merited support, and if all were allocated as recommended in the report then a total of \$31,135 would be granted. He then highlighted a number of projects which were of interest.

There was brief discussion regarding the cottage at Te Horo (known as 'The Kainga') located at 91 Te Waka Road, Te Horo. The application met the funding requirements and it was noted the cottage was registered in the District Plan Heritage Register confirming its historical status.
