Creates risk that existing homes will receive no sunlight and have no privacy. - The area has already experienced an increase in traffic, particularly at the beginning and end of the school day. The Avenue/ Mazengarb intersection becomes gridlocked at these times. - The current infrastrucutre is unable to support the amount of growth from the delvelopment that has occured over last 10 years on Mazengarb rd, the Drive etc. The flooding of the creek passed the creek corridor and into the surrounding properties is regular occurance with all heavy rain. - Permitting 6 story development around the existing local centre would compromise amenity values and be totally out of character with existing developments in the area -The level of commercial activities in the Local Centres (e.g. Mazengarb and Kena Kena) is too low to justify 4-storey buildings within a General Residential Zone 200m walkable catchment.
