PUBLIC SPEAKING TIME (other issues)

- 1. Brian Robb together with Rod Sergent spoke to a paper to the Board regarding various ongoing issues around Rymans Village ie. parking, street sweeping, stormwater, rabbit problem and the noise from dogs at the SPCA.
- 2. Rod Sergent spoke about abandoned vehicles, long grass becoming fire hazards and an open drain hazard. Mr Sergent requested signage to address speeding vehicles.

In response to Mr Robb and Mr Sergent's paper, Group Manager Infrastructure Services, Sean Mallon said a monitoring device would be installed to determine whether measures needed to be put in place to address traffic problems. Speeding vehicles however, needed to be reported to the Police.

Mr Mallon said before a report on the parking issues could be presented to the Board for endorsement, a consultation process needed to be undertaken. Mr Mallon anticipated the work would be completed before Christmas this year.

3. Steve Hollett read from his paper to reactivate the Waimanu Lagoons Focus Group.

The Board agreed it was worthwhile re-establishing the focus group. It also supported work being done to set up a Friends Group. As a starting point, the vacancies would be advertised, followed by the Board considering and appointing nominees.

The re-establishment of the focus group was not currently in Council's work programme and staff commitment would need to be managed through the Annual Plan process next year.
