Approved Owner Status

Who can apply for Approved Owner status?

Dog owners who meet certain criteria can apply to be an approved owner. To be considered you must meet the conditions for approved ownership in sections 6.8-6.10 of Council's <u>Dog Control Policy 2019</u>.

When can I make an application?

Applications for Approved Dog Owner status must be received by 1st May each year to be considered for the upcoming year's registration period (commencing 1st July).

What do I need to do?

Complete this application form & declaration stating that the information provided is true and correct. A one-off, non-refundable processing fee is payable on submission.

Please send the application form and fee to a Kapiti Coast District Council Service Centre. You can do this in person, mail to the address above; or scan and email to <u>dogsadmin@kapiticoast.govt.nz</u>

An Animal Management Officer will review your application and contact you to arrange a property inspection or clarify any points.

We will let you know the outcome of your application in writing once the property check has been completed & a decision has been made.
