New applications for Approved Owner Status must be received by 1 May each year to enable approval for the registration period commencing 1 July.

What do I need to do?

A non-refundable processing fee is payable on submission.

An Animal Management Officer will inspect your property as a consideration to your application.

You will be advised of the decision in writing once the decision has been made.
