PUBLIC SPEAKING TIME (other issues)

Rick Swann

Mr Swan spoke about Road Safety in Reikorangi. Mr Swann suggested the following signs 'beware of falling rocks', 'beware of trucks' and also a couple of signs regarding cyclists on the road that leads into Reikorangi.

Lance Bills

Mr Bills spoke about the Peka Peka Interchange and the need for this to happen. Mr Bills said it doesn't need to be a big interchange; it could even be a small slip road. There is the land available for this to happen and with the Waikanae Town Centre development it would be another opportunity for the traffic to get off and head to Waikanae.

Jeff Ashby

Mr Ashby spoke about the Peka Peka Interchange, stating the Expressway has a 15.5km section with one partial interchange, other areas in New Zealand have more interchanges, and this project needs to keep moving forward.

Glen Brown

Mr Brown spoke about the 1080 drop planned in Reikorangi. This has been scheduled for the end of September through to October. Mr Brown would like to see a local community based trapping project run and he would like to work with this group as he has a background in monitoring and scientific reporting in this area.

Scott McNeill

Mr McNeill spoke about the 1080 drop planned in Reikorangi, saying the notification of this drop was last minute and people weren't informed. Mr McNeill hoped that the water would be tested in this area after the drop.

Ms Stevenson responded that the Ministry of Health haven't advised the Council to take any extra precaution and Council is comfortable that we have robust systems and processes in place to make sure the water supply we're delivering to our community is safe, clean and drinkable.

Brendon King

Mr King spoke on behalf of Rosalind Derby. Ms Derby would like to coordinate a Pop-up in relation to the urban redevelopment at Waikanae Town Centre. Ms Derby is seeking the Board's support to present a formal proposal.

Feriel Falconer

Ms Falconer spoke about Item 7 - Stride n'Ride presentation. Ms Falconer is a member of the Cycleway, Walkway and Bridleway Advisory Group and supports the presentation that the Board will hear tonight.

John Dineen

Mr Dineen spoke about Item 7 - Stride n'Ride presentation. Mr Dineen is a resident of Lavinia Grove and his property backs onto the reserve, the residents are concerned about a proposed shared path beside the Waimeha Stream.

Karl Webber

Mr Webber spoke about the award the Guardians of the Kapiti Marine Reserve received at the Civic and Community Awards. They were awarded the winner of the Heritage and Environment Award and then received the Supreme Winner award. Mr Webber also spoke about the costs for the Welcome to Waikanae sign.

Stu Kilmister, Programme Manager – CWB provided an update on Stride and Ride in Waikanae.

The main focus for year three is the section between Park Avenue intersection up to the Expressway Interchange.

The following points emerged from discussions:

- some of the Board members attended a site visit with Mr Kilmister and discussed the path options;
- the Board discussed the potential removal if four Norfolk Island Hibiscus trees. Three Pohutakawa would be retained. The Board asked that some communications be undertaken with the Community prior to this happening, to ensure that the Community know that some trees will be replaced;
- the standard path width is 2.5 metres, there may be a small section that will be narrowed down to 2.2 metres to allow a tree not to be removed.
- the Board would like to consider trees being planted on the other side of the road to ensure some symmetry along the road;
- the timeframes around this work reflect the need to be finished by July 2018. Staff are looking at completing this section by Christmas, with enrichment planting occurring the following winter;
- the next step would be to do a letter drop to the affected parties and provide information on this pathway, invite feedback and comments on this from residents;
- the Board would like to make sure that communications around this goes out to the whole of the Waikanae Community.

Weggery Reserve – Dogs on Leash Signs

Council are reviewing signage around this area. Mr Seamark has also heard from residents that are replanting in this area and there is a community member pulling these plants out.

Seat for Dr Clive Cameron

Costs have been provided for this seat. The plaque will cost \$450 plus GST and the seat will cost \$300 plus GST. Council staff to look at options on how the Board can cover these costs.

Future Waikanae Beach Vision and Action Plan

An overview of the first draft of the Character Assessment had been shared with the Waikanae Beach working group. The report is expected to be finalised by mid-September.

Waikanae Town Centre Plan

The Board will be having a session on the Waikanae Towncentre connectivity project. Council staff are currently looking at dates for these workshops.

The Board had a discussion around the Library and Gallery upgrade and how we need to make sure that Waikanae becomes a thriving town centre.

Ms Stevenson agreed to follow up with Max Pedersen to confirm the process around the Board being involved in the business case process for the 2018-38 Long Term Plan.

Parking restrictions in Waikanae will start next week.
