ROAD STOPPING – LEGAL ROAD ADJOINING MARINE PARADE, ŌTAKI (CS-17-335)

The report was taken as read and Alison Law, Acting Group Manager Community Services responded to Members' questions.

MOVED (Mayor/Cardiff)

That the Operations and Finance Committee:

- **Agree that 7.4998 hectares of unformed legal road land (Road land) defined as sections 1-4 SO 496960, adjoining Marine Parade, Ōtaki is not required as legal road, but is required for open space and recreation purposes (appendix 1 of report CS-18-335.**
- **Agree that there is no obligation to consider section 40 of the PWA as the Subject Road is required for open space and recreation purposes.**
- **Authorise the Chief Executive to initiate the road stopping process for the Road Land in accordance with section 342 and the Tenth Schedule of the Local Government Act 1974.**
- **Delegate to the Chief Executive the power to formally approve the road stopping and issue the public notice to declare the Road Land stopped as road, subject to all statutory requirements being met, if no objections to the road stopping are received.**
- **Instruct the Chief Executive to arrange a hearing before Council if any objections to the road stopping are received.**
- **Instruct the Chief Executive to present a further report to the Council regarding future status of the Road Land in the event that is it successfully stopped as road.**
