PUBLIC SPEAKING TIME

<u>Alida van der Velde</u> spoke about the memorial to the late Very Rev John Murray, which she had proposed at the Paraparaumu/Raumati Community Board meeting on 21 March 2017. She acknowledged the support of the Board to date, and asked how the matter would be progressed and what the timeframe was.

In response, Mrs McDougall advised that the Council's Parks and Recreation Manager had contacted iwi to request a meeting with them and the Mayor to discuss the matter, and was awaiting their response.

<u>Salima Padamsey</u> spoke in support of Mrs van der Velde's initiative, and asked the Community Board to seek clarification as to which staff member would provide a report which she understood had been requested by iwi.

<u>Chris Turver</u> spoke about the declining health of the Waikanae Estuary. He said there were conflicting messages being conveyed to the public by various authorities, and that an independent review is required to pool the knowledge of the river user groups, to consider options for restoration and to make recommendations.

UPDATE: BUS SERVICE

Rhona Hewitt from Greater Wellington Regional Council (GWRC) provided the following updates:

- GWRC have installed temporary bus stops outside the Paraparaumu Railway Station.
 This work is being done alongside work in the Town Centre being done by the Council; she suggested further questions could be addressed to Michelle Parnell, Council's Infrastructure Programme Delivery Manager.
- An accessibility study is being carried out across the entire rail network; looking at options and costs could potentially guide what happens in Kapiti. This report is due early in 2019
- Suggestions for bus shelter locations were welcomed, and it was noted that locations near retirement villages, schools, shops etc would get a higher rating
- Board members were encouraged to send suggestions to info@metlink.org.nz

- On 30 September, changes were made to morning bus schedules to address the problem of buses and trains not connecting; in addition GWRC were working with the operator to make sure bus drivers are aware they can sit for four minutes after their departure time, if waiting for a train to arrive
- As noted, a disability access review is underway and this will also help to speed up the transit of disabled passengers through stations
- The bus service to the health centre has a long history; the service has been reviewed over the years in conjunction with the health centre and the latest contract has buses replacing the minivan which was used previously. They are still awaiting feedback from the health centre regarding the latest changes. It was noted that in the last month only one person had used the service.
- In Kapiti, there do not seem to be any significant issues since the new timetable was introduced; Ms Hewitt noted that there were still approximately 20% of users paying with cash, and asked Board members to encourage people to purchase Snapper cards

Mr Randall noted that the 9.01am train arriving from Waikanae was consistently 10 minutes late – Ms Hewitt agreed to look into this.

Mrs Spiers advised she had been discussing the bus service at the health centre with Jane Presto of the CCDHB, and would forward Ms Presto's email to Ms Hewitt.

In response to a question from a Board member, Mrs McDougall confirmed that no active work was underway at present with regard to a memorial to Diane Ammundsen, a former Kapiti Coast District Councillor.

Request for central government to fully fund ambulance services

Mrs Spiers asked that this matter remain on the register until a satisfactory outcome is obtained. It was noted that there was currently a vacancy in the role of the Council officer responsible for this item.

Mr Randall left the meeting at 8.44pm and return at 8.46pm.

Saturday Market Policy

There was no further update on this item.

Re-development of the Raumati pool building

Mrs McDougall confirmed that the Ministry of Business, Innovation and Employment (MBIE) had recently confirmed that the Kapiti Coast district was eligible to apply to the Provincial Growth Fund (PGF). She advised that one of the potential projects which was the subject of an earlier expression of interest was the Marine Education Centre (not specifically the redevelopment of the pool building). She said MBIE was taking the lead on community engagement with a broad group of people in Kapiti to explore what could be funded through the PGF, beginning with a public meeting on 30 October 2018.

Town Centres Project

Board members asked to be advised of the following:

- Clarification of the "final minor safety improvements" planned for Rimu Road
- The purpose of the red paint on Rimu Road outside the Council building

Board members agreed to merge this item with Item 1 on the Matters Under Action register.

Redevelopment Plan for Maclean Park

With regard to public art, Mrs McDougall confirmed that concepts had been developed and development of design options based on those concepts would be the next step. The format of the artwork has not been decided.

A separate conversation is underway regarding the installation of something to recognise Te Kahe.

Board members requested that the mousewheel be added to the list of items which comprise the Maclean Park Development Plan matter.

Board members asked where the central pathway was to be located. Ms Waye agreed to circulate this information.

Development of Otaraua Park

A briefing is scheduled for 1 November 2018.

In response to questioning, Mrs McDougall advised there is a proposal for an event in Otaraua Park and an application for funding through the Major Events Fund will be considered at the Council meeting on 25 October 2018.
