There was discussion about the use of certain words in the document. For example, of the terms 'protection' and 'preservation' in the document.

There was discussion about the use of the word 'practicable' e.g. as opposed to the words 'Practical' and 'Possible' throughout the document and their interpretation in terms of the Resource Management Act.

It was clarified that the majority of Kapiti Island is identified as of 'Outstanding Natural Character' with the north end of the island where there has been some development being identified as of 'High Natural Character'.

There was discussion about 'Shared group housing' being a separate term to 'papakainga' which has it's own specific meaning under the Act.

There was discussion about Kapiti Airport and provision for limited new retail activities which would be managed through the Resource Consent process. The provisions recommended by the panel are intended to protect the Council's hierarchal approach of one major town centre with sub-centre arrangements.

Cr M Scott left the meeting at 1.10pm and returned at 1.11pm

There was discussion about the recommended changes in the Proposed District Plan provisions to enable a viable rural economy to be a feature of the Kapiti district.

Cr Cardiff left at 1.20pm and did not return.

It was explained that, while staying within scope of submissions, where appropriate the Panel has had regard to new legislation that has come into force during the course of the Panel's work on the Proposed District Plan.

There was discussion regarding the plans' Tangata Whenua objective.
