About preparing a further submission on a proposed plan change

Certain persons may make further submissions

 - any person that has an interest in the proposed policy statement or plan greater than the interest that the general public has
 - the local authority itself.

The change to a General Residential zone is sensible and logical allowing the properties to be unlocked for development as intended.

- a. have long been signaled for residential development;

- c. fall within the Waikanae North Urban Edge in the KCDC Operative District Plan 2021; and
- d. have already been reviewed in terms of their suitability for residential subdivision (including as detailed in the s.32 Evaluation Report Appendix O (Boffa Miskell 2022)).
