6 UPDATES

6.1 IWI REPRESENTATION ON THE CIVIL DEFENCE COORDINATION EXECUTIVE GROUP (CEG) - JEREMY HOLMES

Bob Hill (Iwi Representative), Joe McLeod (Iwi Representative) and Jeremy Holmes (Regional Manager, Wellington Civil Defence Emergency Management Group) provided introductions and then spoke to a presentation and answered members' questions.

Jeremy provided an update on the Ministerial CDEM review and also around the Regional response to the Ministerial Review. They are seeking an lwi representative from the West Coast - Otaki to Porirua area to sit on the CEG group. The role of this representative is to work with mana whenua, mātāwaka and CEG to:

- provide iwi input into CDEM group governance and planning;
- help the group consult with iwi/Māori on emergency management planning;
- help the group identify marae that could, and want to, have a role in emergency responses and any infrastructure upgrades and training needed to enable those marae to respond effectively;
- held the group undertake planning, understand tikanga and develop protocols with those identified marae that may be required, inlcuding to support reimbursement for welfarerelated expenses.

The main points that emerged from discussions were:

- CEG meetings are quarterly;
- work that has been done around planning for Marae's around Civil Defence events and what has been learnt from Christchurch and Kaikoura;
- barriers around compliance rules for Marae continueng the dialougue with Council and Maraes;
- working with rangitahi to help with civil defence planning and preparation

Koro Don Te Maipi acknowledged the korero and thanked Bob, Joe and Jeremy for coming and presenting.

6.2 STORM WATER WORK PROGRAMME

Rita O'Brien (Stormwater & Coastal Engineer) spoke to a presentation and answered members' questions.

It was agreed that Te Whakaminenga o Kāpiti would **ratify** who will host the Waitangi Day Commemorations for 2020 at the next meeting, but discussions would take place in the next two weeks to confirm who will host.
