PURPOSE OF REPORT

- 1 Six applications for funding have been received:
 - Kapiti Coast Quilters
 - Kapiti Coast Rugby League Club 2004 Incorporated
 - Kapiti Food Fair
 - Kapiti Light Orchestra
 - Kapiti Songsters Choir
 - Wellington SPCA

DELEGATION

- 2 The Paraparaumu/Raumati Community Board has delegated authority as at section D of the Governance Structure approved by Council on 26 October 2016:
 - Approving criteria for, and disbursement of, community-based grant funds as approved through the LTP or Annual Plan

BACKGROUND

- 3 An amount of \$21,893 is provided in the 2016/17 budget for the Paraparaumu/Raumati Community Grants Fund and is available for allocation in that financial year.
- 4 In the current financial year to date the amount of \$7,877.60 has been granted, leaving \$14,015.40 available for granting.
- Accountability reports on grants allocated are required two months after the event or activity for which the grant was awarded takes place.
- 6 All applicants have been advised of the meeting date by email or mail.

CONSIDERATIONS

Policy considerations

7 Grants are allocated in accordance with established criteria (attached to this report as Appendix 1).

Applications to the Community Grants Fund

Kapiti Coast Quilters

- Funding of \$500 is sought to assist with the costs of holding the Kapiti Coast Quilt Exhibition at the Southward Theatre on 29 30 April 2017.
- 9 This activity can be considered under Eligible Purpose 2: Special Project or Activity.

Kapiti Coast Rugby League Club 2004 Inc.

- 10 Funding of \$500 is sought to assist with the cost of paying for the fields at Matthews Park, which is the venue for the Horowhenua Kapiti Tag season.
- 11 This organisation was last granted funds on 8 December 2015, which is less than the 12 months required in the criteria. However Board members are reminded they have the authority to consider any application at their discretion. The next Board meeting is not until 7 February 2017.
- 12 This activity can be considered under Eligible Purpose 2: Special Project or Activity.

Kapiti Food Fair

- 13 Funding of \$500 is sought to assist with the costs of the entertainment programme at the Kapiti Food Fair, to be held on 3 December 2016.
- 14 This activity can be considered under Eligible Purpose 2: Special Project or Activity.

Kapiti Light Orchestra

- 15 Funding of \$500 is sought to assist with the cost of purchasing music for the orchestra to rehearse and perform.
- 16 This activity can be considered under Eligible Purpose 2: Special Project or Activity.

Kapiti Songsters Choir

- 17 Funding of \$500 is sought to assist with the cost of hall rental fees at the Kapiti Uniting Parish Church.
- 18 This organisation was last granted funds on 8 December 2015, which is less than the 12 months required in the criteria. However Board members are reminded they have the authority to consider any application at their discretion. The next Board meeting is not until 7 February 2017.
- 19 This activity can be considered under Eligible Purpose 5: *The remission of hall rental*.

Wellington SPCA

- 20 Funding of \$500 is sought to assist with the cost of providing a low cost animal desexing programme to the Kapiti Coast.
- 21 This activity can be considered under Eligible Purpose 2: Special Project or Activity.
