Request for Official Information responded to under the Local Government and Official Information and Meetings Act 1987 (LGOIMA) (the Act) – reference: OIR 2122-248

I refer to your information request we received on 2 May 2022 for the following:

- 1. I would like to know how many work-related or on-the-job injuries to staff and contractors to the council were recorded from the beginning of 2021 to now. Can this please be broken down by:
 - Month
 - Whether the injury required medical treatment or hospital care
 - Whether the injured person had to take time off work and for how long
 - What type of injury
 - What department the injured person worked in

Please see attached Appendix 1 containing a summary of the work related or on the job injuries to staff and contractors for the period 1 January 2021 until 16 May 2022 when this response was collated. Appendix 1 contains information relating to the type of injury, when the injury occurred and what area of the Council the staff member (or contractor) worked in.

Of the total 39 such injuries reported there were eight which required medical treatment. Three staff required off site medical treatment due to trips and stumbles on pavement/steps, one required medical treatment for a finger laceration, and three received first aid. One contractor was hospitalised for treatment following a burn to the hand.

One staff member with the finger laceration was off work for one week following their injury.

2. I would also like copies of incident reports for these injuries. Can identifying details be redacted so privacy is not an issue.

Copies of incident reports have not been provided because after having completed redactions to protect the privacy of our individual staff and contractor, under section 7(2)(a) – to protect the privacy of natural persons, the information remaining in the reports is covered in Question One and Appendix One.

3. I would also like copies of any emails, correspondence, or memos relating to these injuries and/or relating to any policies enacted due to these injuries.

The Council's injury management process requires injuries to be reported using the Council's H&S management system (VAULT) to enable a consistent approach for all injury related information to remove the reliance on ad-hoc individual emails which may contain important and relevant information for the event. Relevant emails associated with injuries may, where appropriate, be included with incident reports however there are no supporting individual emails attached for these injuries.

Emails between the Council and its Contractor in relation to the burn injury are withheld on the basis of section 7(2)(a) – to protect the privacy of natural persons.
