Request for Information under the Local Government Official Information and Meetings Act 1987 (the Act) (the LGOIMA)

Thank you for your email of **21 February 2024** requesting the following information:

Mr Webber, an elected member of the Paraparaumu Community Board, contacted me today and informed me (in writing), that CAP had sent CRU a letter of invitation on 18 January (year unknown).
