Currently there are no buildings and just trees along the fence line offering privacy and and a sound barrier, and it is unknown whether there are plans to remove the trees as part of the proposed development.
If the trees are removed, and new multi-storey dwellings constructed close to the boundary to the allowable height limit, this will negatively affect privacy (including via a rooftop skylight) and quiet enjoyment of our homes for myself and my immediate neighbours. Any such structures will overlook my property and impact the light and sunshine shaft.
I am not opposed to development of the site per se, but wish to see the height of proposed new dwellings along the east/west boundary capped at no more than four storeys, and not sited within several metres of the boundary. Ideally the trees will also be retained to provide a visual and sound barrier for residents on both sides of the boundary.
