Tēnā koe ,

Request for Information under the Local Government Official Information and Meetings Act 1987 (the Act) (the LGOIMA)

Thank you for your email of **29 April 2025** requesting the following information:

- 1. The total number of designated mobility (disability) parking spaces managed by your council on public land.***

There is a total of 136 disabled parking spaces on Kāpiti Coast District Council land.

- 2. Private Land Data: Information on any disability parking spaces located on private land (e.g., shopping centers, hospitals) that your council has records of or oversight responsibilities for.***

There are requirements under the District Plan for private developments to provide disabled parking.

This information is not held by Council in a format that can be produced without staff manually going through large numbers of files to compile this information from consent documents and aerial photographs. Accordingly, this part of your request is refused under section 17(f) of the Act as the information requested cannot be made available without substantial collation or research.

Consideration has been given to whether your request could be further refined. However, in this particular situation we do not consider this would be possible. I have also considered whether we would be able to respond to this part of your request given extra time, or the ability to charge for the information requested. I have concluded that, in either case, the Council's ability to undertake its day-to-day work would be significantly impacted.

Please note that any information provided in response to your request may be published on the Council website, with your personal details removed.

3. A list or summary of their locations, such as addresses, street names, or approximate locations.

4. Whether these spaces are generally aligned with current New Zealand Mobility Parking Standards (in terms of dimensions, signage, access aisles, etc).

- *If detailed compliance assessments or reports are available, I would be grateful if you could share them.*
- *If such assessments have not been undertaken recently, a brief description of the council's approach to mobility parking (e.g., design guidelines or standard practices) would be helpful.*

Because they involve a change to parking, new spaces require a Council Resolution via the Community Boards, and this has to be supported by a report detailing the process and consultation involved. An example can be supplied.

All new spaces are built to meet AS/NZS 2890 or NZS 4121 standards where possible, but some compromises have to be made at times where the benefit of providing a sub-standard space outweighs not having one at all. A lot of older spaces were provided at incorrect dimensions and others that may have the correct dimensions lack fully accessible ramps. These get upgraded as and when time and money permit.
