APRIL 2015 UPDATE ON THE PROPOSED DISTRICT PLAN (SP-15-1541)

Senior Policy Planner Katherine Dorofaeff spoke to the report, highlighting engagement and internal activities, as detailed in the table within the report. There had been several meetings with submitters regarding specific issues and a site visit to Kāpiti Island which was hosted by Ngāti Toa. Site visits between staff, iwi and landowners concluded with strengthened relationships. There had also been a formal prehearing meeting relating to coastal issues attended by some iwi.

Mr Lew mentioned the government's financial incentive scheme for landowners with regenerating native bush. A fully drafted District Plan was expected to be circulated to submitters by the end of May and engagement would continue for the next 4-6 months, including on waahi tapu sites. It was clarified that iwi who had not been submitters, but whose iwi had submitted would be able to provide support in this context.

Mr Lew introduced new staff Sally Matich, Planning Technician and Suzanne Rushmere, Policy Planner.

Te Whakaminenga o Kāpiti 15/04/162 **2015 REPRESENTATION REVIEW – UPDATE (CORP-15-1552)**

Ms Starbuck-Maffey spoke to the report explaining that Council had embarked on its review of representation arrangements as required by the Local Electoral Act, including the appointment of a Working Party with an iwi representative. A series of public workshops would be hosted by Community Boards and then the Working Party would make a recommendation to the Council on a possible model for the initial proposal. Following this the public would be able to formally submit. A final proposal would be decided by Council in August and appeals or objections could be made at that point. This would trigger the matter being referred to the Local Government Commission (LGC) for a final decision on the arrangements that would apply to the 2016 local body elections.

It was clarified that notwithstanding the LGC reorganization proposal under consideration by the region at the moment Council was required to proceed with the review until such time as it was certain that regional change was inevitable.

It was also clarified that the iwi representative on the Working Party would be paid for this work through the Te Whakaminenga o Kāpiti budget.

MĀORI ECONOMIC DEVELOPMENT GRANTS 2014-2015 – ALLOCATION OF FUNDS (SP-15-1546)

Iwi Relationship Manager Monica Fraser reported back on the distribution of the grants, which had been awarded to three out of the five applications. The successful projects were:

- Kāpiti Island Nature Tours further support of glam-camping by assisting with the installation of two shower and composting toilet units
- Establishment funding for Kāpiti Island Manuka Honey business
- Production of the Māoriland Film Festival in Ōtaki.

Ms Hakaraia was commended for the process she managed. Accountability reports would be circulated soon. ART would be reviewing the strategy.

UPDATE: SUBMISSION TO DRAFT LONG TERM PLAN (LTP) - KEVIN BLACK

Corporate Reporting and Planning Manager Kevin Black spoke to this item, noting that the consultation period had opened on 20 March and would close on 24 April 2015. The Consultation Document (CD) and call for submissions had been well-publicised through the Sustainable Home and Garden Show as well as through a series of LTP 'Open Days' held throughout the District and a display attended by Councillors at Coastlands. Public comment had been positive as had feedback from the Office of the Auditor-General. To date just over 100 submissions had been received.

The Council would be briefed on 12 May about the submissions and their issues and public hearings of submitters was scheduled to run between 18 and 22 May, depending on the number of submitters wishing to speak.

The Council would adopt the LTP on 25 June. Iwi were invited to attend the hearings and briefings and a timetable would be distributed to iwi members so that their presence could be coordinated. Staff were commended on their hard work, especially in the promotion of the CD.

Ngā Hapū o Ōtaki

 Cultural Impact Assessment (CIA) work had recently been undertaken in respect of a non-notified resource consent for the pumping of stormwater from Moana Street to Ōtaki Beach. This had included a site visit. CIAs were only required for notified resource consents, but there were some non-notified ones that required CIAs and this was an important issue for further discussion by ART and Te Whakaminenga o Kāpiti together with Council officers

Te Whakaminenga o Kāpiti 15/04/166 **COUNCIL UPDATES**

The Chief Executive Pat Dougherty provided an update:

- Large projects including the Proposed District Plan (PDP) and LTP were proceeding
- Blessing of the River Recharge Scheme had been held
- Kevin Currie had been appointed as the new Group Manager Regulatory Services and Sharon Foss was thanked for her excellent job acting in the position
- The Expressway project was progressing with a heavy workload: 27% had been completed and beams across Kāpiti Road were expected to appear by the end of June.

The Mayor arrived at 11.12am.

- PP2Ōtaki NZTA would be advertising this in 2016, focus is to make sure the Expressway has the same look and feel as the preceding sections
- Local government reform the LGC has finished hearing submissions, and thanked this Council for its courtesy and professional approach. It remained to see whether the Commission would issue an amended proposal or withdraw it completely as there did not seem to be much support for it in the region
- The Waikanae Community Board had held a Strategic Planning Day recently
- The Council meeting this Thursday would feature the Council's submission to the GWRC LTP with particular comment on the timetable for the Whaitua Approach and a request for the regional council to focus on coastal hazards issue management.

MAY 2015 UPDATE ON THE PROPOSED DISTRICT PLAN

PURPOSE OF REPORT

1 This report summarises activities carried out since the last update provided to Te Whakaminenga o Kāpiti on14 April 2015.

DELEGATION

2 This report is for information purposes and does not seek a decision.

BACKGROUND

On 24 July 2014, the Council chose Option 4 recommended by the Independent Review of the Proposed District Plan (PDP). This option is to continue with a modified PDP process which addresses the Plan as a whole using the 'basket of tools' available to the Council.

EXTERNAL ENGAGEMENT ACTIVITIES

The following table lists the external engagement activities that have taken place since the last update which recorded activities up to 1 April 2015.

- 5 The key internal activities undertaken by staff since the last update include:
 - Participation in Town Centres and Connectors meetings to ensure coordination with the PDP.
 - Continuation of internal and external review of redrafted chapters. Internal
 review is by the Resource Consents team. External review includes a
 planning review by Sylvia Allan (consultant planner) and a legal review by the
 Council's lawyers (Simpson Grierson).
 - Continued work with the Council's GIS team to PDP planning maps in response to submissions and also to improve the presentation of the maps for the Submitter Engagement Version.
 - Integration work to address 'whole of plan matters' and ensure consistent approach to key issues across the PDP.
 - Preparation of an engagement plan for the next phase ie release of the Submitter Engagement Version of the PDP.

• Detailed project planning on the logistics of production and publication of the Submitter Engagement Version.

CONSIDERATIONS

Policy considerations

6 There are no policy considerations that need to be referenced.

Legal considerations

7 There are no policy considerations that need to be referenced. As noted above, the Council's solicitors, Simpson Grierson, are providing legal input into the preparation of the Submitter Engagement Version of the PDP.

Financial considerations

8 Costs to date are within budget for the 2014/15 financial year.

Implementation plan update

- 9 The implementation plan is attached as Attachment 1.
- 10 The timeline has been adjusted to allow an additional two works for internal work on the Submitter Engagement Version prior to making available to submitters. The release date is now 15 June rather than 30 May 2015. This will allow additional time to work on integration and production aspects.

Tāngata whenua considerations

11 There are no specific tāngata whenua considerations in this update report. A meeting with the Tāngata Whenua working party are recording in the table under External Engagement Activities. The PDP engagement plan will include a series of workshops with the Tāngata Whenua working party.

SIGNIFICANCE AND ENGAGEMENT

Degree of significance

12 The PDP is now in the statutory phase between close of submissions and commencement of hearings. As the PDP process has already been adopted by Council this report has a low degree of significance.

Engagement

- 13 The PDP implementation plan (refer to Attachment 1) provides for additional submitter engagement and prehearing meetings which are not required under the RMA.
- 14 An engagement consultant has been retained and is preparing a detailed Engagement Plan for the Submitter Engagement Version of the PDP. A communications Action Plan will be prepared to align with the Engagement Plan.

Publicity and communications

15 There is a Communications Plan for the PDP. In line with this, a regular PDP Update Newsletter will be provided to submitters in May. The newsletter will give submitters a brief summary of what they can expect with the roll out of the Submitter Engagement Version of the PDP on Monday 15 June.
