We oppose the recommendation in S122.112 to amend the Local Centre building height to enable building heights of up to 18 metres (5 storeys) in Waikanae Beach in the area marked 'Height Variation Control' on the Waikanae Beach map contained in Appendix 4 of the submission (the area). In the Decision Requested column this request has been interpreted as 45 storeys which I presume is a typo error.

Natural Hazards

1. The recommendation does not take into account inundation caused by natural hazards to which the vast majority of the area is subjected to. Many of the properties in the area have been subject to inundation from rainfall from December 2021 to September 2022. This is not surprising as most of the area prior to 1920 was either a lake, river or swamp. The river was diverted in 1920 and the lake drained in 1921 by W H Field to enable the area to be subdivided and sections sold in 1923 and 1925.

The present-day consequence is that the former swamp, river, stream, lakes and low-lying areas are prone to flooding.

Coastal Hazards

2. The recommendation also does not take into account coastal hazards and in in particular Policy 25(b) of the New Zealand Coastal Policy Statement 2010 (NZCPS) which reads -
