Thank you for your email of **1 March 2024** requesting the following information:

I am requesting copies of all communication/documentation including emails, minutes to meetings from KCDC pertaining to their involvement and leading the decision to cancel the 2024 primary interschool swimming sports.

The decision to cancel the 2024 event was made in consultation with the sports representatives from each of our Kāpiti primary schools at the end of last year.

The Kāpiti School Sports Programme delivers over 20 events per year for our region, and we aim to make each event as inclusive and as enjoyable as possible. Each event is measured to ensure it meets with the required outcomes of the Kāpiti School Sports Programme. The interschool swimming sport numbers have been declining and we were seeing attendees who were already well catered for through regional swim clubs in Kāpiti.

Please find attached e-mail correspondence and minutes from the coordinator meeting from Kapiti Coast District Council pertaining to the cancellation of the 2024 Primary Interschool Swimming Sport.


