As this area is reserve land I would like to see the public have access to this area. Grazing cattle from time to time may be incorporated to the plan but I request that the public are able to access this reserve land at least the majority of the time. I would support W Read grazing only if the term was shorter and access to all the reserve land for public granted. I also question the least cost - it seems much lower than the going rate for grazing in our area - I would ask this be reassessed to check it is a suitable amount. Reson being Peka Peka resident numbers are growing and continuing to grow.
