				Improvement work in Mahara Place continues to progress well. Rubbish bins have been installed and planting is completed. The final pour of concrete has been done and the lights are now up and working.	
				Final touches to be completed include the installation of hand-rails, slip resistant studs and strips to stairs and ramps, and removing Council's site sheds and equipment. This work is expected to be completed in early August, weather permitting.	
4		October 2019	Waikanae Police Base	Letters to the Police Commissioner, Area Commander Inspector, Regional Commander and the Minister of Police were sent on 12 March 2019, requesting reinstatement of the Police Base in Waikanae. Inspector Tracey Thompson provided an update at the Board meeting of 18 June 2019.	
				Police have been working with Council staff and Mr Westbury. Local police have scheduled regular foot patrols in Waikanae for increased visibility and accessibility, and other measures to better enable a police presence in Waikanae are being looked into.	
5		December 2019	Signage Audit	The Signage Audit has been completed and the information collated will assist in developing guidelines to provide and install signage. These guidelines are expected to be completed in the current calendar year.

7		Parking in Waikanae	A summary of the parking changes in Waikanae follows:  1. The double rail tracking to the Waikanae station and the upgraded parking at the station was completed in 2011  2. Parking in Pehi Kupa St was extended by Council in 2015 to provide more parks  3. Extensive consultation and work was undertaken to formulate the Waikanae Town Centres Parking Strategy Stage 1 in 2015  4. This Waikanae Town Centres Parking Management Strategy was refreshed in 2016 as Stage 2. The key focus of this strategy is:  a. Firstly to optimise existing space and assets and free up more parking capacity through turnover of parking  b. Then increase enforcement  c. Final stage is to investigate paid parking  5. Reports were taken to Community Board 2015-18 to adjust the time limits of parks as part of reviewing and optimising space and parking  6. The new GW car park was opened in 2017 (240 parks)  7. Increased parking on the shoulder of Old SH1 was completed earlier in 2019 as part of revocation  The Traffic Bylaw is being reviewed next calendar year, which will be the time to review any issues such as permit parking that may be included in the Bylaw.  We also have a review planned this fiscal year around some of the parking issues that we have across the district. The scope of this is yet to be finalised, but it may be that this incorporates, or commences with, a further review of the Waikanae issues.
