6.1 WAIKANAE TRANSPOWER CONDUCTOR REPLACEMENT PROJECT

Ms Selina Corby and Mr Jonathan Mason from Transpower New Zealand Ltd spoke to the report, which was taken as read, and gave a Powerpoint presentation.

There was discussion about Transpower's Community Care Fund and the types of projects it supports; Ms Corby invited people to contact her directly for further information.

Key messages were that when work on the project begins there will be a noticeable increase in activity, publicity and personnel on site and a Transpower liaison person will be based at the sports buildings in Waikanae Park.

When asked about their previous visit to the Board discussing maintenance of trees in Waikanae Park below the power lines Ms Corby and Mr Mason confirmed there had been conversations with the Council regarding this but an agreed work programme was yet to be finalised. Mr Jefferson agreed to follow up.

The Chair thanked Ms Corby and Mr Mason for attending the meeting and welcomed the consultation they had carried out in preparation for doing this work.

7 UPDATES

7.1 VERBAL UPDATE - KĀPITI COMMUNITY CONSTABLE

Constable Brett Polglase and Sergeant Yvette McKelvie attended the meeting and spoke to this item. Sgt McKelvie advised they had looked at the concerns raised by the Board regarding police visibility in the area, and have done some work around that. Cst Polglase, who has main responsibility in the Waikanae area, has been more active in the area since the concerns were raised. He is carrying out foot patrols at least three times a week; front line response staff have also been tasked with foot patrols, and there are always mobile patrols driving through.

They are looking at potential spaces for police to hold visits/meetings with the public. The library place is considered unsuitable for an extended visit and they have not yet identified an alternative. They are visiting local businesses and last week carried out a crime prevention survey with 38 businesses. Most businesses said there were no problems and the police are working individually with those businesses who have reported thefts, to offer crime prevention advice. Police noted it was important that businesses formally report incidents even if there may not be enough evidence to support a prosecution.

Skateboarding in Mahara Place has been raised as an issue and the police will work with those caught and the Council to see what can be done to discourage this.

The Waikanae community is lucky to have a visible and supportive community patrol, who are now spending time doing day time patrols.

It was noted that the marked police car park space is now being used by the general public, and Board members asked whether it was intended that this be repainted. Mr Jefferson agreed that this would be looked into by Council staff.

Board members asked questions of Sgt McKelvie and Cst Polglase, and stated they felt more regular visibility was needed. An increase to daily patrols would be ideal. Board members also expressed disappointment at the lack of progress in identifying a location for a police presence.

The Chair thanked Sgt McKelvie and Cst Polglase for attending the meeting, noting that the police and the Community Board needed to work together to investigate ways to increase police profile.

7.2 ECONOMIC DEVELOPMENT STRATEGY REFRESH

Ms Leanna Hill, Senior Economic Development Advisor, talked to a high level presentation on the Economic Development Strategy refresh, and sought feedback from Board members. She advised that the strategy was intended to be finalised in February 2020, with implementation in March 2020, but the document was not yet available for review. It was noted that the strategy applies districtwide, and that some of the options will affect each community differently.

Ms Hill took questions from Board members and invited them to provide feedback to either herself or to Mr Jefferson, before 11 October 2019.
