# ALCOHOL LICENSING AND REGULATORY AUTHORITY (ARLA) ANNUAL REPORT JULY 2015 TO JUNE 2016

#### **PURPOSE OF REPORT**

#### 1. OVERVIEW OF DISTRICT LICENCING COMMITTEE (DLC) WORKLOAD

#### DLC's structure and personnel

The DLC Chairperson is Councillor Diane Ammundsen.

The DLC Deputy Chairperson is Councillor Murray Bell.

We have five list members as noted below:

- Hilary Wooding
- Samantha Sharif
- Michael Dodson
- Trevor Knowles
- Philip Parkinson

The Secretary of the DLC role is delegated to Kevin Currie, Group Manager Regulatory Services.

The Committee Advisor is Jacquie Muir, Environmental Standards Manager.

In addition Committee support roles are shared between staff in the Secretary's and Council's Democracy Services teams.

The Inspectorate was fully resourced in September of 2015, enabling other Environmental Health Officers to return to their normal duties. The Inspectorate team have significantly reduced the backlog of renewal applications. They are now processing all applications for Temporary Authorities, New Licences or Certificates, Renewals and Special Licences in a timely manner.

With regard to the Inspectorate, we currently have the following team members:

- One full time Alcohol Licensing Inspector
- One full time Alcohol Licensing Inspector/Administrative Officer
- One Chief Licensing Inspector, the team leader of Environmental Health, contributing approximately 50% FTE
- The Business Improvement team have also helped with improving templates and undertaking continuous improvement initiatives.

Any staff training undertaken relating to the Sale and Supply of Alcohol Act 2012

One List member attended a workshop run by the Health Promotion Agency on scoping a professional body for DLC members.

- One Licensing Inspector attended the NZILLI Conference this year.
- One Licensing Inspector attended a week long course on Warranted Officer Training provided by CERT Systems.
- One Licensing Inspector and one Food Officer undertook LCQ training.
- In house training and peer review is carried out on a regular basis within the team.

# Change in business compared with the District Licensing Agency under the Sale of Liquor Act 1989.

After almost three years operating under the new Act, most renewal applications for licensed premises and manager's certificates have been renewed. Most licensees and managers are aware of their new responsibilities under the Act and understand that Inspectors are not the decision making body when it comes to determining alcohol applications.

#### **DLC** hearings or meetings

The DLC convened 22 Temporary Authority Hearings.

There were seven other hearings:

- New Managers Certificate Lynch declined
- New off-licence bottle store Lion Liquor Retail granted
- New off-licence bottle store Blackbull Liquor (Pangotra Enterprises) granted
- Renewal of off-licence Raumati Beach Four Square renewed
- New off-licence bottle store Waikanae Liquor Centre granted
- New off-licence bottle store Otaki Liquor Limited declined
- New off-licence located in a tavern Salt and Wood Collective granted

On 25 September 2015 the DLC heard an application brought by Pangotra Enterprises Limited for a new off-licence bottle store in respect of premises to be located at Unit 2, 119 Kapiti Road, Paraparaumu. This decision of the DLC was appealed by Police pursuant to s 154 of the Sale and Supply of Alcohol Act. ARLA subsequently declined the appeal and upheld the decision of the DLC and the licence was granted.

The DLC met as a group once this year to discuss issues.

#### Any noticeable trends or issues faced by the DLC

The Pangotra Enterprises Limited application and the Otaki Liquor Limited application for new off-licences highlighted the community's increasing awareness and interest in communicating their opinion and objections to new alcohol licence applications. This among other recent applications for new off-licences highlighted a knowledge gap for some community groups comprehending the process of objecting. This included writing objections based on the criteria, writing quality submissions for hearings and presenting evidence at hearings. This is an issue for both DLC during hearings and for community groups wishing to express opinions through submissions at hearings.

A current initiative is the joint approach taken by Police, MOH and Licensing Inspectors working with off-licence bottle stores (new and renewal applicants) to agree to reduce opening hours back to 9pm. When no agreement is reached applications have generally been opposed by one or all of the reporting agencies.

#### 2. DLC INITIATIVES

#### New initiatives adopted or tried by the DLC

The Council is directly notifying all Elected Members and Iwi group representatives from (Te Whakaminenga o Kāpiti, Te Āti Awa, Ngāti Toa Rangatira) and Iwi representatives to standing committees of Council of all applications related to new and renewal of licences.

The Inspectorate has undertaken process mapping of all of their procedures as a first step to implementation of a Quality Management System.

#### 3. LOCAL ALCOHOL POLICY

# Does the Territorial Authority have a draft or provisional Local Alcohol Policy, and if so, any comment on this?

The Kāpiti Coast District Council is in the early stages of developing a LAP and this work is being prioritised with Strategy and Planning. The development has not progressed as quickly as initially planned, mainly due to the large and increasing policy work programme. However, the development of a LAP remains a high priority for the Council.

The DLC, Inspectors, and the Community continue to be concerned about off-licence applications of bottle stores and are keen to see the LAP progress.

#### 4. CURRENT LEGISLATION

#### Any comment on the Sale and Supply of Alcohol Act 2012?

The way the requirements for the different licence types are spread through various sections in this Act is still a problem for Inspectors, especially when training staff.
