MATTERS UNDER ACTION

Placement of Toilet at Ōtaki Estuary

There are some complex resource consent issues to be resolved. The chosen location is a contaminated site; it has a Waahi Tapu designation in the proposed district plan and is an ecosite.

Tasman Road Speed Issue

There are speed humps at one end but not the other; cars need to be slowed around the bend. Council are looking at the design around the west end and timing of those works is to be confirmed.

The Board asked for the following to be added to the matters under action list:

- Container on Council land at Gawler Street at Te Horo Beach, a service request has been lodged.
- Winstones lake working with Greater Wellington Regional Council on this to get an easement.

Community Board Members' Activities

The Chair has met with a representative from the Problem Gambling Foundation of New Zealand about reducing gambling in Ōtaki. They will attend a future Board meeting for further discussion.

Cr Cootes updated the Board that Elevate Ōtaki had met with NZTA. Cr Cootes asked if there could be a Council briefing on the Revocation Project, including the Railway Station and Te Horo.

It was suggested that ZEAL attend a future meeting to provide an update to the Board.

It was noted that the Chair will be accompanying the Mayor to visit Council flats in Ōtaki on 14 August. The Board Members queried why some flats have been empty for 3 months; this would be looked into and details would be emailed to Members.
