PUBLIC SPEAKING TIME

Amanda Dixon spoke to the funding application from Kapiti Songsters Choir, and invited Board members to attend the Christmas Concert being held at the Kapiti Uniting Parish Church Hall on 10 December 2018, at 7.30pm.

Cr Vining arrived at the meeting at 7.02pm.

Alida van der Velde spoke about her request for a memorial to the late Very Rev John Murray. She stated that she had met with Andre Baker on behalf of local iwi, and Mr Baker stated that iwi were supportive of the suggestion but were awaiting the report referred to in the minutes of the Council meeting dated 13 April 2017. She asked what could be done to progress the matter.

In response, Cr Benton advised that Mayor Gurunathan was attempting to set up a meeting with Mr Baker. The Chair and Mrs McDougall advised that they were waiting to receive confirmation that iwi supported the suggestion before a report could be prepared, and Mrs McDougall advised it was her understanding that the Mayor and Chief Executive had met to discuss the matter. It was noted that although the April 2017 Council minutes stated that a report would be prepared, this statement was incorrect.

MOVED (Burns/Benton)

That the Paraparaumu/Raumati Community Board requests that Council staff prepare a report on the naming of a memorial to the late Very Reverend John Murray, to provide to iwi as soon as possible.

Mrs Spiers voted against the motion.

Mr Dale Evans spoke about the grant application from Kapiti Youth Support, for funds to assist with the cost of a venue for hosting an after-function for Anzac Day commemorations. He asked how much the Council and the Paraparaumu/Raumati Community Board had granted to Kapiti Youth Support in the current financial year, and also asked whether other options had been considered.

In response, Cr Benton advised the Paraparaumu/Raumati Community Board had granted Kapiti Youth Support \$312.50 in the current financial year. Mrs McDougall advised she would need to find out the amount granted by the Council to Kapiti Youth Support as she did not have that information to hand. Cr Benton suggested that other options would be looked at when the item came up for debate later in the meeting, and Mrs Spiers stated other options had already been considered.

CONSIDERATION OF APPLICATIONS FOR FUNDING (CS-18-695)

MOVED (Randall/Benton)

That the Paraparaumu/Raumati Community Board grants 'Actively Coping with Cancer Programme' \$500 to assist with the cost of hall hire for the community based programme for cancer patients and their support Whanau.

CARRIED

MOVED (Randall/Vining)

That the Paraparaumu/Raumati Community Board grants Kapiti Songsters Choir \$500 to assist with the cost of hall hire for weekly choir rehearsal sessions.

CARRIED

MOVED (Randall/Burns)

That the Paraparaumu/Raumati Community Board grants Kapiti Youth Support \$3,581 to assist with the cost of a venue for hosting an after-function for Anzac Day commemorations.

Mrs Spiers spoke to the application, saying that the event proposed provides an opportunity for people whose family fought or died in armed conflict, to get together and share their stories. It is also important to remind young people of the importance of Anzac Day. She stated that granting this application would not set a precedent and that funds were available as there are only three meetings left in the current financial year and there is still \$10,657 remaining in the budget.

Mr Burns stated that this was one of few grants received that in his opinion had clear community benefit.

MOVED (Vining/Best)

That the Paraparaumu/Raumati Community Board defers consideration of the grant application from Kapiti Youth Support until their next meeting.

Cr Vining expressed concern that based on the budget provided, it would cost \$35 per head to provide the morning tea. She also sought confirmation that the RSA were in full support of the suggestion. She acknowledged the importance of acknowledging the sacrifices made by men and women in the armed services but was concerned about the cost of the proposed event and thought other options should be considered.

Further discussion points included the importance of the event to the entire community, the level of support from the RSA and how much support is already being provided to Anzac Day activities by the Council.

The motion was put and a division was called for:

The Chair used his casting vote in favour of the motion.

Redevelopment Plan for Maclean Park


The Board Chair and Council staff were thanked for organising the recent walkabout at Maclean Park.
