Request for Information under the Local Government and Official Information and Meetings Act 1987 (the Act)

Thank you for your email of 31 July 2022 requesting the following information:

Can you please provide me the dates, topics discussed, list of attendees and any minutes or notes produced, from any formal meetings between Greater Wellington Regional Councillor Penny Gaylor and any KCDC councillors or the Mayor, during the current triennium.

For the avoidance of doubt, this does not include any casual interactions such as a conversation at an event, and is limited solely to meetings - whether in person, online or over the phone - that involved GWRC Councillor Gaylor and at least one Councillor or the Mayor from KCDC.

I'm not interested in emails at all - only in meetings (both in person and via Zoom) with Councillors or the Mayor, not with staff, since the 2019 election.
