### 4 PUBLIC SPEAKING TIME

### Citizen's Advice Bureau Kapiti

Sue Lusk thanked the Board for the grant of \$500.

The Board agreed that, together with the Kapiti Community Patrol, the Citizens Advice Bureau do a great job and help towards a safe and caring community.

### Combined Lions Club of Kapiti

Sue Leen, on behalf of the Combined Lions Club of Kapiti, spoke to their grant application requesting help with purchasing leaflets for the Foodbanks of Kāpiti and Ōtaki.

The Board acknowledged their great work in assisting the Foodbanks.

Bede Laracy

Mr Laracy thanked the Board for their help around the area in the last three years and thanked Cr Vining for her efforts during this triennium.

The Chair commented there would be a review of the work around Raumati Village.

Raumati South Residents' Association (RSRA)

Trevor Daniell, on behalf of the RSRA, spoke about their concerns around land owned by the New Zealand Transport Agency (NZTA), in Raumati South, that had been previously allocated for the Western Link Road and was now surplus to requirements and ready to be sold.

Their concerns were:

- residents of Leinster Avenue walk through tracks in the vacant land to catch the bus (there is
  no service in Leinster Avenue and the alternative is via Poplar Avenue) for both Raumati
  South school pupils and others travelling to the town centre wants this to be maintained;
- previous plans was to insert a roadway through the Leinster playground to access the vacant land; this playground is well used by local children and should be retained; and
- the southernmost area of this land is designated an ecological wetland (it has the only significant stand of Kanuka and wetland in Kāpiti) and the Council must ensure this is protected.

The Chair advised he was aware of surplus land being disposed of and this area of land would be added to the matters under action to enable the Board to continue to monitor.

Mike Freeman, on behalf of the RSRA, spoke to their grant application requesting help with funding towards the continuation of the Argentine Ant Baiting programme.

Rosie Solas

Ms Solas, Arts, Museums and Heritage Advisor, gave a brief summary of the Maclean Park Artwork Commission by Kereama Taepa (paper was tabled). The artwork is called Tohora, which means southern right whale. When the detailed designs are finalised they will be put forward to the Public Art Panel for final approval.

It was clarified that:

- the Public Art Panel has the delegation to commission and approve the artwork; and
- there would be signage around the artwork when installed to let the community know the background of the artwork.

It was advised that there was no further information about when the Kiwiriders artwork would be uplifted.

Copies of the Kapiti Arts Guide, which included the Kapiti Arts Trail, was given out at the meeting
