The Chair welcomed members of the public and introduced members of the Community Board and Council staff in attendance.

**PRCB 18/03/095  
APOLOGIES**

Apologies were noted from Mayor Gurnathan who was unable to attend, and from Greater Wellington Regional Councillor Penny Gaylor, who would be arriving late to the meeting.

**PRCB 18/03/096  
PUBLIC SPEAKING TIME**

Brian Sullivan, accompanied by Gabrielle Ashdown, spoke to the application from Community Connections for funds to assist with the cost for people with disabilities to go on a day trip to Kapiti Island in April 2018.

Mr Peter Bain spoke to the application from Kapiti Community Patrol for funds to assist with general running costs.

Mr Lynn Sleath spoke about walking tracks in Queen Elizabeth Park, and in particular the Coastal Track which had been damaged in recent storm events. He was hopeful that Greater Wellington Regional Council would rebuild the track rather than close it, and suggested relocating it further inland.

Ms Jill Stansfield spoke about the Ngatoto Trig on Realm Drive, advising that it had been recognised as a Heritage Site since 2004 and she was concerned about erosion and degradation of the land at the site. She would like to see the site preserved in some way.

Mr Ben Knight spoke on behalf of the Guardians of the Kapiti Marine Reserve, providing an update on the proposal made to the Council as part of the Long Term Plan (LTP) consultation. The proposal is to collaborate with the Council and other key stakeholders to investigate the feasibility of a marine education, research and activity centre at the former Raumati Pool building. He was concerned that in the new draft LTP, redevelopment of the building has been pushed out to 2026 – 2028. He would like the Board to support the proposal to take the plan to the feasibility stage, and invited Board members to walk around the site with him to see what the Guardians have in mind.

Mr Warwick Halcrow spoke about the Paraparaumu Beach market. He advised that a large piece of land on which the market is sited has been sold for development, meaning there is a

limit on how long the market can remain at its current location. Representatives of the market wish to obtain an alternative site in reasonably close proximity to its current site. Local businesses are supportive, and surveys/petitions are currently being circulated. Possible alternative sites include Maclean Park and/or the western portion of Maclean Street. Mr Halcrow asked the Board to put a resolution to the Council supporting the retention of the beach market in as close a proximity as possible to Paraparaumu Beach.

Mr Kevin Jones spoke in support of Mr Halcrow, suggesting the Council could assist the market by helping to work through the various regulations that would need to be considered.

Ms Sharon Hunter also spoke in support of Mr Halcrow, confirming the local business community is very supportive of the market. She advised that Council staff have indicated willingness to help with logistics and she was also planning to investigate what would be required in order to have the road closed while the market was operative.

Mr Trevor Daniell spoke on behalf of the Raumati South Residents Association. He advised that the weekend after Easter, residents affected by Argentine Ants would be laying baits, and later in the year he would be approaching the Board for a grant to lay baits in springtime, when they would be most effective. He asked the Board to request that Council submits to Greater Wellington Regional Council that it include Argentine Ants in its Regional Pest Management Strategy.

Ms Stansfield was advised that Board members would discuss the matter with Council staff. There may also be iwi issues to be addressed.

Mr Knight was advised that Board members would arrange to have a site visit at the former Raumati pool building, to discuss the Guardians' ideas.

Mr Halcrow, Mr Jones and Ms Hunter were advised the Board was very supportive of having the Paraparaumu Beach Saturday market continue.

The matter has reached crisis point and the associated violence and abuse is horrific. Mrs Spiers said that methamphetamine is easier to buy in Kapiti than any other drug.

Request to Council to write to Minister of Transport requesting that they instigate a review of NZS 6806:2010 (Acoustics – Road-traffic noise – new and altered road) as to whether it is fit for purpose for residential night time noise.

It was noted this letter has been sent, and it was agreed this item could be removed from the Matters Under Action register.

Request to Council to write to Local Government New Zealand for support in requesting that Central Government fully fund all ambulance services in New Zealand.

Re-development of the Raumati pool building

The Board agreed to carry out a site visit with the Guardians of the Marine Reserve. The Chair agreed to liaise with staff to arrange a suitable time.

Reduced speed through Raumati South Village

Progress on this item was noted.

The Chair advised Board members that sealing work planned for Raumati Road has been changed from chipseal to asphalt. The timing of this work is dependent on budget available.

Town Centres Project

Progress on this item was noted.

Expressway Update

It was noted that the Community Liaison Group, along with the Makarini Street and Leinster Avenue Neighbourhood Impact Fora (NIF), each have one more meeting before winding up.

Mrs Spiers advised that there remains one outstanding issue from the Leinster Avenue NIF, which is the right-turning bay into Leinster Avenue. Modelling has shown that a right-turn bay is unnecessary, however the NIF believe this is necessary due to development planned for the area. The Board agreed to add this issue to the Matters Under Action register.

Redevelopment Plan for Maclean Park

Board members advised their preference is that the 'Kiwi Riders' sculpture should be located somewhere within Maclean Park. Mr Pedersen confirmed that would be included in the report which will go to Council, however the report would need to include iwi consultation.


Sale of land at Paraparaumu Railway Station


Board members noted that access to the public toilets at the Paraparaumu Railway Station would no longer be available after 15 July 2018, as the land is owned by Mana Transport and has been sold. The bus depot will be relocated to Te Roto Drive.

Development of Otaraua Park

Mr Pedersen confirmed that the Council will receive a briefing in April 2018. It was noted there was no second entrance to the park at present, but a location for a second entrance had been secured.
