# CONTRACTS UNDER DELEGATED AUTHORITY

# **PURPOSE OF REPORT**

1 This report provides an update on any contracts over \$250,000 accepted under delegated authority for the period 1 July to 31 September 2018.

### Delegation

2 The Operations and Finance Committee has delegated authority to consider this report under the following delegation in the Governance Structure, Section B.2. *This Committee will deal with monitoring and decision-making on all broader financial management matters, including approval of contracts and contract variations outside the Chief Executive's delegations.* 

# CONSIDERATIONS

### Issues

#### Contract 2018/C188 – Engagement of consultant for building control services

- 3 Four tenders were received. No contract value. Hourly rates for technical staff ranged between \$117-\$189 per hour and the cost of the service depends on the efficiency of the processor and the complexity of the consent being processed.
- 4 Type of Contract Open panel, measured by weighted attribute and framework agreement.
- 5 The procurement plan was for a maximum of \$600,000 for 3 years across all panel contractors (currently two panel contractors). Budget current financial year \$186,660 and standard increases for out years.
- 6 The Contract was awarded to National Processing Ltd. Technical staff \$140 per hour (excluding GST) plus administration.
- 7 National Processing Limited's office is local and their processing staff work remotely.

#### Contract 2018/C201 – Engagement of consultant for building control services

- 8 Four tenders were received. No contract value. Hourly rates for technical staff ranged between \$117-\$189 per hour and the cost of the service depends on the administration and disbursement costs, the efficiency of the processor and the complexity of the consent being processed.
- 9 Type of Contract Open panel, measured by weighted attribute and framework agreement.

- 10 The procurement plan was for a maximum of \$600,000 for 3 years across all panel contractors (currently two panel contractors). Budget current financial year \$186,660 and standard increases for out years.
- 11 The Contract was awarded to Solutions Team Ltd. Technical staff \$117 per hour (excluding GST) plus administration and disbursements.
- 12 No local content.

Contract 2018/C178 - Road Maintenance 2018 - 2021

- 13 1 tender was received.
- 14 Type of Contract weighted attribute method in accordance with NZTA competitive pricing procedures.
- 15 The Contract was awarded to Higgins Contractors Limited for the sum of \$13,827,480.
- 16 Maintenance and renewal of the network roading assets, with NZTA subsidy applicable in most instances.
- 17 Higgins Contractors Limited is a local company.

### Considerations

18 There are no financial, legal, consultation and publicity considerations.

19 The Council's significance policy is not triggered.
