**Re: Kapiti Coast Proposed District Plan – Confirmation of Designations for Education Purposes – Minister of Education**

Thank you for your recent recommendations (Your reference: RM190208 and RM190209), in accordance with Section 171 of the Resource Management Act, in response to the Notice of Requirement for the following two existing school sites:

1. St Peter Chanel School, 2 Covent Road, Otaki; and
2. Kapiti Primary School and Ngahina Kindergarten, 20 Iver Trask Place, Paraparaumu.

The purpose of this response is to confirm the designation information to be included in the Proposed Kapiti Coast District Plan.

Council's recommendation to the Minister of Education is summarised below:

*That pursuant to the authority delegated by the Council to the District Planning Manager and pursuant to section 171(2) of the Resource Management Act 1991, the District Planning Manager recommends to the Minister of Education that the following designation be confirmed and included in Schedule 11.3 of the Proposed Kapiti Coast District Plan.*
