Request for Information under the Local Government Official Information and Meetings Act 1987 (the Act) (the LGOIMA)

Thank you for your email of **7 March 2025** requesting the following information:

I would like a list of all occasions the representatives from "Concerned Ratepayers Kāpiti" or "Concerned Ratepayers Wellington Region" or "Concerned Ratepayers" spoke during public speaking time at council meetings, met with council officials/councillors and a copy of any submissions the organisation submitted.

Please list the name of the representatives.

Please note that this response is limited to only including instances where a person has explicitly identified themselves as being a member of "Concerned Ratepayers" and that they are speaking for/representing the group. Unless the members have made this identification, it is assumed they are acting in their individual/private capacity.

Attendance at Council and Community Board meetings

A search of our records has found two occasions when a speaker identifying themselves as a representative from Concerned Ratepayers Kāpiti has attended a Council or Community Board meeting and spoken during public speaking time. The first instance was at the Council meeting on Thursday, 6th March 2025 and the second instance was at the Raumati Community Board meeting on 12 November 2014. Both times the person identified themselves as Chris Harwood.
