Request for Information under the Local Government Official Information and Meetings Act 1987 (the Act) (the LGOIMA)

Thank you for your request for information received [REDACTED] on 25 July 2023. You asked the following question:

What is the reason for NOT informing affected building owners that they are in the coastal adaption area as I'm sure there would be a lot more people here today sharing their thoughts?"

Building owners are not affected by being in a "coastal adaptation" area. The adaptation areas for Takutai Kāpiti sets out a wide area that may be affected by coastal erosion and/or inundation which the Coastal Advisory Panel are focusing on. These adaptation areas are not intended to delineate 'hazard areas' nor have any meaning for district planning purposes.

It is predicted that pockets within each adaptation area may be impacted, whilst other are untouched. A public interactive map was created so the community could see the projected impacts of sea level rise within the district for individual properties. The interactive map shows the potential effects of sea level rise at a property level and gives an indication of the impacts of either erosion or inundation. The impacts are predicted to be different depending on which sea level rise scenario is being used and at what timeframe.


