#### About preparing a further submission on a proposed plan change

#### You must use the prescribed form

- <u>Clause 8</u>, Schedule 1 of the Resource Management Act 1991 (RMA) requires further submissions to be on the prescribed form.

- it would be an abuse of the hearing process to allow the submission (or the part) to be taken further

- it is supported only by material that purports to be independent expert evidence, but has been prepared by a person who is not independent or who does not have sufficient specialised knowledge or skill to give expert advice on the matter.
