The Proposed District Plan has included provision for papakainga housing in the rural zones. Appeals to the Proposed District Plan close this week and staff will subsequently report back to Council and to Te Whakaminenga o Kāpiti. It was a recommendation from the Independent Hearings Panel that Council look at papakainga as a future workstream. The iwi management plan project is about to start which, it could be expected, will cover this topic.
