UPDATE: KAPITI COAST DISTRICTWIDE SPEED LIMIT REVIEW – STAGE 2

Kevin Black, Acting Group Manager of Strategy and Planning provided an update on Stage 2 of the Speed Limit Review. Stage 2 will review the remaining rural roads, three village centres (Paekākāriki, Raumati South and Raumati Beach these have all been outlined in a table given to Board members. Consultation will start on the 5 February 2019 and will run for four weeks. Staff will then review submissions and prepare recommendations to go to Council.

The Board had a brief discussion around the Provincial Growth Fund (PGF) and what this could look like for Ōtaki. Cr Cootes was talking to MBIE in regards to organising a dedicated workshop for the Ōtaki community – this would be the time to look at projects for the Ōtaki area.

- the Pekapeka Interchange.

Toilet at the Estuary

The Resource Consent and the Building Consent had been received. The Council is currently in the process of tendering for quotes for installation.

Tasman Road

Council staff met with Higgins on site and measured up for a new full width hump and some adjustments to the signage.

The sign adjustments were carried out immediately but the new hump requires a paving team to come up from Wellington so this had been booked in for December.

Council staff still need to meet Higgins at the Marine Parade and Moana St sites to programme in the new pedestrian refuges there.

Tennis Courts

The draft lease document and draft MOU is with the Otaki Sports Club for their review. The access for the public is being worked through currently.

Ōtaki Railway Station

LINZ has indicated that they will have funding available for works at the station building from November this year. The first steps will be to go out for quotes for the restoration works and these would then need assessment and approval.

The planned scope of works includes:

- demolition of the two brick chimneys;
- demolition of the brick dividing wall; and
- repairs and repaint of the exterior cladding
