Members were comfortable with the contents of the Report but felt it did not capture Councillors' input and support governance from an operational point of view. Governance was influenced by political and community factors so requested this be included within the Framework.

Grant Taylor, Partner at Ernst & Young confirmed that most Councils around New Zealand had an Enterprise Risk Management (ERM) Framework in place. The overall cost to implement the ERM would be funded from the 2014/15 Annual Plan and the 2015-35 Long Term Plan.
