MATTERS UNDER ACTION**

The following items were discussed from the Matters Under Action list:

Item 1 – Pedestrian Crossing at Ōtaki Beach

Staff have had a safety review done for Ōtaki Beach, which has looked at traffic calming and pedestrian refuges on Tasman Road and Marine Parade. There is not high enough year-round pedestrian flows to justify permanent “zebra” crossings at Ōtaki Beach. Staff have passed the review on to a couple of Community Board members and interested members of the public and hopes to consult and construct the pedestrian refuge in the next financial year.

The Board asked if Council staff could relook at this as they considered that a pedestrian crossing is needed.

Item 2 – Footpath on the Main Street in Ōtaki

Staff have spoken to the Concrete Doctors who undertook the Ōtaki Main Town Centre segmental paver sealing. This trial has not been successful. Staff have agreed to drop off some spare pavers to the Concrete Doctor to see if they can now look at a trial on colouring existing pavers, or alternatively these will have to be replaced with a darker colour. The Community Board will need to decide what areas are to be coloured or replaced, if the trial proves successful.

Item 3 - Northern Entrance Sign

Three designs have been approved, which will be changed throughout the year. Professional photographs are being taken based on the approved designs. The next stage will be printing onto canvas and erecting the signs.

The Chair discussed a request for a plaque from St Johns Ōtaki to acknowledge Kevin Crombie and the work he has done for this Community. Also as part of the discussion the Board decided on what the remainder of the Ōtaki Community Grants fund was to be used for.
